our key accomplishments included:

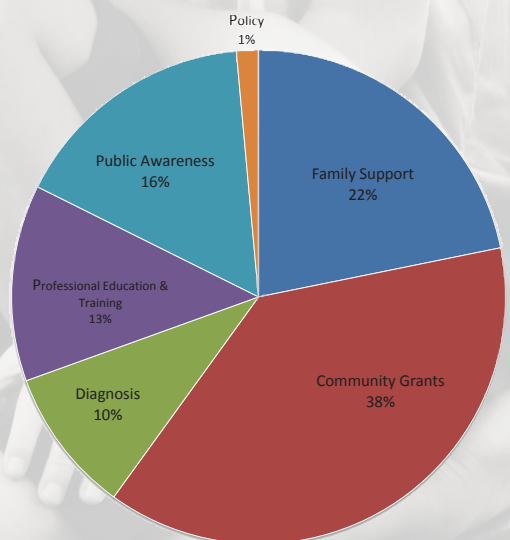
- Bringing the 049 campaign to life and reaching over 7,000 people at baby expos, Pregnant Pause_{em} events, the MN State Fair and even on Nicollet Mall.
- Providing 527 diagnostic appointments throughout Minnesota which give families an opportunity for awareness, understanding and ultimately a feeling of empowerment.
- Hosting 120 parents and 220 children at family camps and family fun nights where they can come together, be themselves, have fun and connect with others who understand.
- Expanding family support statewide with the addition of five Family Resource Coordinators who bring programs, support, awareness and advocacy activities to parents in their own communities.
- Piloting a program with Minneapolis Public Schools that incorporates prenatal alcohol exposure questions at all early childhood screenings. Of the 3000 kids screened, two percent (60 kids) were identified with emotional, behavioral and/or learning delays due to prenatal alcohol exposure and will be monitored for further school readiness issues.
- Training over 3,250 health care professionals, social workers, care givers, educators, parents, chemical dependency workers, juvenile justice workers, police officers, students and policy makers around Minnesota to ensure that FASD is better understood.
- Awarding nine new community grants to health care facilities to begin maternal alcohol screening, referral and follow up programs.
- Sharing of personal FASD stories by over 100 advocates with 60 legislators at the 2010 FASD Day on the Hill. The goal was to ensure that policy makers understand how their decisions impact families and individuals affected by FASD.
- Volunteering over 1000 hours by 100 volunteers to provide trainings, exhibit at conferences, data entry and help at events so MOFAS could spread the 049 message and meet the needs of families around Minnesota.
- Launching the Circle of Giving (those who give \$500 or more) with 17 members. Combined, they are giving over \$23,000 annually. This commitment provides an important source of sustainability which enables MOFAS to improve and expand our prevention and intervention work.
