2016 MOFAS annual report this year, because of you...

our key accomplishments included:

- Spreading the 049—zero alcohol for nine months—prevention message face-to-face to 10,000 women
 across Minnesota at baby showers, baby expos, health fairs, resource fairs and community events, and to
 16,000 people through our College Ambassador Program and public awareness grantees.
- Distributing nearly 95,000 public awareness materials to providers serving women of childbearing age, from county human services agencies to family medicine clinics.
- Reaching nearly 250 alcohol industry leaders in Minnesota with tools to spread the 049 prevention message at alcohol points of sale.
- Assessing 94 Minnesotans from toddlers to young adults for a Fetal Alcohol Spectrum Disorder (FASD), which in turn can help families access the services and supports needed to be successful.
- Expanding capacity to screen for prenatal alcohol exposure through partnerships with three counties, a state board and two community agencies and training over 100 professionals on screening.
- Reaching 530 attendees with education and support at women's treatment centers, domestic violence shelters and correctional facilities through Changing Course, a series designed for birth mothers with substance use disorders.
- Providing support and technical assistance to three innovative long-term recovery support programs for women in recovery from alcohol and other substance use disorders. Of babies born this year to women in these programs, 95% had no prenatal exposure to alcohol or other drugs.
- Connecting with caregivers nearly 2,000 times across the state through individual contacts, support groups and at meetings in settings such as schools, human services appointments and children's residential facilities.
- Hosting 315 young people and caregivers at family retreats, family events and youth and young adult activities.
- Partnering with over 60 governmental, nonprofit and community organizations to train over 4,500 people
 across the state, from human services, education and criminal justice professionals to people with an FASD
 and caregivers.
- Increasing FASD prevention and support programs in Minnesota by providing 21 community grants related to FASD screening, employment services, culturally specific programming, legal advocacy, family support and social and life skills programs.
- Drawing over 150 advocates—a record number—to FASD Day at the Capitol. Advocates educated over 70 legislators on FASD in Minnesota. Because of the strong commitment of our advocacy community, MOFAS passed legislation requiring all new foster parents to receive training on FASD. Milestone legislation!
- Raising \$42,000 and growing awareness of our vital work through our 9th annual golf classic and 13th annual benefit.
