PRIMARY DUTIES AND RESPONSIBILITIES:

- Facilitate monthly skills group for high school age youth with fetal alcohol spectrum disorders (FASD).
 - Monthly groups are 1.5 hours and located in-person in St. Paul at Proof Alliance office
 - Program Manager will provide support in planning monthly skills lessons
 - One additional adult (staff or volunteer) assists with supervision during groups
- Build rapport with youth, foster healthy peer connections, model effective communication and provide effective supervision during in-person activities
- Participate in required FASD training and behavior strategies, youth protection plan policies, background check and program onboarding
- Track attendance and complete required documentation

QUALIFICATIONS:

- Experience leading/facilitating groups or activities for youth with an FASD and/or intellectual or developmental disabilities in a recreational, educational, or camp setting strongly preferred
- Enthusiasm for working with youth of all abilities and backgrounds
- Strong interpersonal, problem-solving, and conflict-resolution skills
- Ability to work the second Saturday of each month in St. Paul, MN
- Have good written and excellent verbal communication skills
- Proven ability to work within established systems and take direction
- Successful completion of background check and safety policy procedures
